

Invoicing addresses for Vendors of Veho Oy Ab

We only accept electronic invoices. If you are unable to send electronic invoices from your billing system, you can use free supplier e-invoice portal. To register for the service, please visit:

Invoices circulate more swiftly within our system when they include our official billing address. The purchaser's name, the supplier's official name and address, and other reference information (VAT-code, E-invoice address, e-invoice operator ID) should be clearly stated on the invoice. The purchaser's name and branch/department information must always be referenced. Attachments should primarily be sent together with the invoice. If attachments cannot be included with the invoice, they should be sent as PDF files via email to **ostolaskut@veho.fi**. The email message should specify which invoice the attachments correspond to.

Please note that we only process invoices with accurate information. Incorrect or incomplete invoices will be flagged for corrections. Also, the agreed-upon payment term will not start counting until we have received an invoice with accurate information.
